

Terms & Conditions to sellers / stallholders

Bookings & Cancellation -

All bookings are made on a first come first served basis.

If paying by Direct Bank Transfer /Cheque, all payments should be made within 7 days of receipt of your stall booking confirmation. Bookings can be made verbally, by email or via the My Mum's baby and kids market website.

If payment has not been received within 7 days, the table will be re-allocated to other customers.

If the booking is made within 7 days of the sale, then immediate payment is required.

If there is non-attendance on the market day, a refund will not be issued.

Should you wish to cancel your booking then you will receive a refund if it is more than 14 days before the market date. Cancellation less than 14 days will not be refunded but can be transferred to another date, where applicable.

If My Mum's Baby and Kids Market have to cancel an event due to unforeseen circumstances such as weather conditions, health and safety or any other reason that My Mum's baby and Kids Market feel is out of their control, then stallholders will be offered to transfer their booking or receive a refund.

My Mum's Baby and Kids Market reserve the right to refuse acceptance of a reservation or admission to the market to any person's without giving any reason.

Venue -

All stallholders are financially responsible for any damages they may cause. Please do not affix any items in any way to the wall, floors, curtains or doors or to any part of the building during your time at the venue.

My Mum's Baby and Kids Market reserve the right to arrange the tables on market day and will consider any requests as to the placement of the stalls prior to market day, should they feel it beneficial.

Any unsold items must be taken away with the seller and their rubbish should be removed from the venue.

My Mum's Baby and Kids Market organisers accept no responsibility for any transaction entered into within the market venue/enclosure.

Refreshments –

Any refreshments and/or food purchased at My Mum's Baby and Kids Market is done so at the buyers own risk. We do not hold responsibility for any accidents\spills with hot or cold drinks.

All food is purchased at the buyers own risk. My Mum's Baby and Kids Market do not hold responsibility for any allergies/reactions which may occur.

Health and Safety -

Health and safety is of paramount importance to My Mum's Baby and Kids Market and we look to promote high standards at each event. In relation to the Health and Safety legislation, stallholders are responsible for all activity at their stall for the duration of the event. Any stallholders who do not adhere to these requirements will be asked to leave the venue.

My Mum's Baby and Kids Market organisers reserve the right to decide or arbitrate any dispute arising out of, or in the course of conduct of the market.

If any stallholder brings a child along with them at the event, it is their responsibility to maintain the child's safety and wellbeing at all times during the event.

My Mum's Baby and Kids Market accept no liability for the theft, loss or damage of any personal/ items on sale from the stallholder's stalls, or other items within the boundaries of the event.

All people who enter the venue do so at their own risk.

Security –

Stallholders are responsible for their own stall security and monies at the event, which includes the time setting up and packing up. You need to ensure that you keep your monies with you at all times and do not leave any valuables unattended at any time.

Vehicles and their contents are left in the car park at the owner's risk.

My Mum's Baby and Kids Market accepts no liability for any theft, loss or damage caused to vehicles, accessories or contents incurred whilst on the premises and/or loading and/or unloading your goods for the market.

When using the car park please park with consideration to other driver's.

Illegal Activity –

My Mum's Baby and Kids Market shall not be held responsible for the non-compliance by a stallholder with any Law, By-Law, Regulation, Act or Statute.

Stallholders cannot sell –

Any items or services unrelated to babies or kids or items which are seen to be broken, in poor condition, dangerous, in breach of Health and Safety legislation or trading standards advice. My Mum's Baby and Kids Market organisers reserve the right to request items are removed from sale which they feel do not adhere to our standards or guidelines.

Promotional materials available at stalls may only relate to the product / service on sale at the stall. Stallholders are not permitted to distribute advertising or promotional material ie walking around the venue handing out promotional materials, putting flyers on cars etc. A breach of these conditions will result in the stallholder being asked to leave the event.

Selling –

Items you are selling should be in a fully working order, not damaged or incomplete.

Prams and Pushchairs

Buggies and strollers sold in the UK should comply with British Standard BS 7409. The pushchair itself must display the British Standard label and detail the year it was made, ie BS 7409 2008.

This law applies to the sale of second hand buggies/strollers as well as new and sellers should ensure that the item is of good construction and stability. It has a built-in 5-point harness, older models may have a 3-point harness and the brakes should function properly.

The manufacturer's instruction manual should also be included.

Car Seats

For health & safety reasons it is recommended that you do not sell a second hand car seat/infant carrier.

Electrical Items

If you wish to sell second hand electrical items such as a steam steriliser or mains powered bottle warmer, for health & safety reasons the law states that all second hand electrical items must be tested properly by a competent person before being sold and must include the manufacturer's instruction manual.

Liability –

The stallholder agrees to indemnify My Mum's Baby & Kids Market against all claims for damages or injury to the property or person of any persons in respect of any claim by any such person arising out of negligence on the part of the stallholder or his agents or servants.
